Re: Open Records Appeals - Log Numbers 201600105 and 201600061

Dear Ms. Pawson:

As you know, this office is currently reviewing the two above-referenced open records appeals involving the University of Louisville. In the discharge of its duties, this office has previously corresponded with the University pursuant to KRS 61.880(2)(c) in both of these appeals.

- Log Number 201600105: On March 11, 2016, the University was asked to describe how it conducted its search for "documents, reports, and other information" in President Ramsey's possession that caused him to suspend the University of Louisville men's basketball team from post-season play. In addition, we asked that the University describe how it conducted its search for "documents, reports, and other information" in the custody of other parties "such as an administrator or a program director." (Emphasis added.) The University's response is based on an erroneous belief that Dr. Hesselbacher's request was confined to "document, reports, and other information" that Dr. Ramsey had "in hand on February 4 when the decision was made."
- Log Number 201600061: On April 14, 2016, the University was asked to provide for *in camera* review an unredacted copy of the requested records, which consisted of all materials "requested by the NCAA"

from 1/1/2014 through present date" or "issued by the University of Louisville in response to a request by the NCAA from 1/1/2014 through present date." The materials you provided for our review contained no reference to the matter under investigation by the NCAA that has led to the suspension of the men's basketball team from post-season play in 2016.

Both of the open records appeals relate to materials regarding NCAA investigations. The appeals include requests for documents related to the widely reported NCAA investigation of the men's basketball team and tha allegations which led to the decision to forgo post-season play. However, while you do not specifically state, your responses to both of the aforementioned requests for additional documents indicate that you do not possess any records related to this investigation. We are, therefore, compelled to request additional information and further *in camera* review of records.

- 1. With regard to both appeals, please state whether any records exist relating to the NCAA's investigation into the widely reported allegations concerning the men's basketball team and Mr. Andre McGee, former director of basketball operations, which led to the decision to forgo post-season play.
- 2. If such records do exist, please provide them to our office for *in camera* inspection. Pursuant to KRS 61.880(2)(c), we acknowledge our obligation not to disclose these documents.
- 3. With regard to Log Number 201600105, please describe in detail the search method used to locate responsive records, including but not limited to the search method used to locate "records in the custody of other parties such as an administrator or a program director."

Please respond to these inquiries within seven calendar days of the date of this letter. In responding, please bear in mind that records in the custody of an attorney, investigator, or other agent of the University are not thereby excluded from the reach of the Open Records Act. A public agency cannot avoid producing records responsive to an open records request by placing public records in the hands of a contracted employee or a non-public entity.

As always, please provide the appellants in the respective appeals with a copy of the University's written response (excluding documents submitted for *in camera* review). We appreciate the University's anticipated cooperation in this matter.
